REMINDER....QUALIFICATIONS FOR YEAR END AWARDS ARE:

Must be a member in good standing.

Must participate in a minimum of one more than half of shows for that discipline.

Must work a minimum of one hour for every show you participate in

Must attend three monthly DCSC meetings.

Must work two workdays or concessions at two Deep Dixie show on our DCSC grounds.

**TWO MINUTE GATE CALL WILL BE STRICTLY ENFORCED, ALL DOGS MUST BE KEPT ON A LEASH, NO ONE 18 YEARS OF AGE OR UNDER CAN SHOW STALLIONS, NO ALCOHOLIC BEVERAGES ALLOWED ON SHOW GROUNDS**

Note: All classes with "like classes" can be combined with a "like class" if there are less than 5 entries. Points will be credited as if separate classes were held. Classes without a "like class" will be held with less than 5 entries. Club members will accrue points toward year-end awards. Due to the number of classes on the show sheet, there will be no added classes unless there are 3 or more participants.

Each entry shall be subject to the bylaws and show rules of the Dougherty County Saddle Club. A copy of these bylaws and show rules are provided to each club member at the beginning of the year. A copy of the rule book will be available at all shows for non-members to review. All contestants (members or non-members) are responsible for reading and understanding the show rules and regulations.

Each entry shall be subject to the bylaws of the Dougherty County Saddle Club and agrees to be guided by the rules of United States Equestrian Federation (USEF) and the Dougherty County Saddle Club. The Day of Show Committee, consisting of three Club Officers and/or Board Members will settle any disputes. Their decision is final.

ALL Huntseat Class riders under 18 must wear an ASTM safety helmet. Helmets must be secured with strap or rider will be excused. All Western class riders under 18 must wear Western Hat or Approved Protective Headgear.

Classes must be registered two classes prior. Once you have registered for a class you are required to pay for that class.

Classes must be scratched two classes prior, or entry fee will be forfeited or can be used toward another class for that rider on that show day. Awards will be given 1st through 6th place in all classes with the exception of where noted.

Tack changes must be requested two classes prior to your class.

Proper attire/equipment required in all classes. You will not be permitted into the show ring if you are not in proper attire with the exception of the Walk Only and Academy classes. Schooling attire and tack are permitted in Walk Only and Academy classes (the attire is not judged), Polo Shirts are not permitted.

Academy Class are for riders of ages who are in their first two years of showing in the discipline at a Walk-Trot. Academy Class riders can ride in other walk-trot classes (in proper attire and show tack) but are restricted to walk-trot classes only.

Open Walk-Only classes will be allowed a side walker. Lead line cannot be attached to the horse. Horse must be bridled. Saddle must fit rider. Proper headgear and footgear are required Walk only participants are restricted to riding in walk only classes.

ALL Horsemanship/Equitation Classes will include pattern and rail work.
